

Uride Referral Program – Terms and Conditions

Effective Date: May 6, 2026

These Terms govern the Uride referral program ("Program") offered by Uride Technologies Inc. ("Uride", "we", "us"). By participating, you agree to these Terms.

1. Eligibility and Scope

- Open to registered Uride Rider app users in Canada who are the age of majority in their province or territory.
- Valid only in cities where Uride operates ("Uride Cities").

2. How the Program Works

Referrer

- May invite a new user ("Referee") via email or SMS using a referral code.
- Will receive a push notification with a coupon code when the Referee successfully registers and completes their first ride.
- Must redeem the reward manually in the app within thirty days of receiving it.

Referee

- Must download the app, register, and enter a valid referral code received via the referral email or SMS during sign-up.
- Receive a reward after successful code entry.
- Reward is valid only for the Referee's first trip and will be auto applied.

3. Referral Rewards

- Both Referrer and Referee will receive **\$5 each in promotional credit** ("Reward") after the Referee completes their first eligible trip.
- Rewards are:
 - Issued as in-app credit only

- Non-transferable, non-refundable, and have no cash value
- Subject to availability and verification of eligibility
- Rewards:
 - Expire **30 days** from issuance (Referee) or redemption (Referrer)
 - Are valid only for card-based payment methods
 - May be subject to additional limits displayed in the app

4. Geographic Limitation

- Rewards apply only if the Referee's first trip occurs within a Uride City.
- Uride reserves sole discretion to determine eligibility of trips and rewards.

5. Communications and CASL Compliance

Uride complies with **Canada's Anti-Spam Legislation (CASL)**.

- By sending a referral, the Referrer confirms they have obtained consent (express or implied) from the recipient to receive the invitation.
- Referrals must only be sent to individuals with a personal or existing relationship.
- Unsolicited bulk messaging, automated distribution, or misuse of referral communications is prohibited.
- Uride communications will identify Uride and include unsubscribe mechanisms where required by law.

6. Misuse and Withholding of Rewards

Uride may, at its sole discretion and without notice:

- Withhold, delay, cancel, or reverse any Reward
- Suspend or terminate user accounts

This applies in cases of:

- Fraud, abuse, or gaming of the Program
- Self-referrals or duplicate accounts
- Any violation of these Terms

7. Changes and Termination

- Uride may modify, suspend, or terminate the Program at any time.
- Continued participation constitutes acceptance of updated Terms.

8. Liability and Privacy

- Uride is not liable for indirect, incidental, or technical issues affecting the Program, to the extent permitted by law.
- Personal information is handled in accordance with Uride's Privacy Policy.

9. Governing Law

These Terms are governed by the applicable laws of the province or territory in Canada where the user resides and the federal laws of Canada.
