Short Form of Rules

There is 1 prize of \$5000 available each week for a total of 4 prizes. A mathematical skill-testing question must be correctly answered to win. The odds of winning depend on the number of entries received. The contest begins at 12:00PM (EST) on February 1, 2026 and ends at 11:59PM (EST) on February 28, 2026. Limit 1 entry per week

Official Contest Rules

3. Eligibility

. Student Eligibility & Verification

Potential Winners will be required to To confirm eligibility, students must submit **any two** of the following documents:

- Valid student ID (**mandatory**)
- Enrollment / confirmation letter

- Current semester tuition or fee receipt

Sensitive information may be blurred before submission.

Limit **one entry per person per week**. Multiple entries will be void. Any attempt or suspected attempt to use robotic, automatic, programmed or otherwise illicit means to enter the Contest, or any other methods not authorized by these Contest Rules, for example, but not limited to, creating multiple accounts, identities, or registrations, all in the Sponsor's sole discretion, shall be deemed as tampering and may disqualify you from entering, participating and/or winning a prize.
