

# Uride Good Deeds Program: June Canada Match Experience Giveaway

## Short Form of Rules

Potential winners are expected to be announced on or around **June 4, June 11, and June 18, 2026**, subject to eligibility verification, travel availability, completion of all required documents, and compliance with the Official Contest Rules. Additional eligible comments with two friend tags may count as additional entries. ## 1. Sponsor

## 2. Contest Period

The Contest begins on **May 25, 2026** and ends on **June 18, 2026** the “Contest Period”.

Entries submitted before or after the Contest Period will not be eligible.

Potential winners are expected to be announced on or around **June 4, June 11, and June 18, 2026**, subject to eligibility verification, travel availability, completion of all required documents, and compliance with these Official Contest Rules.

**The third potential winner is expected to be announced on or around June 18, 2026 after the Contest closes.**

The Sponsor’s computer or designated timekeeping system is the official timekeeping device for this Contest.

## 3. Eligibility

To be eligible to participate in the Contest, an individual must meet all of the following requirements at the time of entry and at the time of selection:

- Be a legal resident of Canada;
- Have reached the age of majority in their province or territory of residence;
- Reside in a city where Uride actively operates, each an “Eligible Uride City”;
- Be a current Uride customer with an active Uride account in good standing;
- Be legally able to travel within Canada;
- Be available to travel on the dates required for the applicable prize;
- Be able to provide valid government-issued identification upon request;

By participating in this Contest, Entrants acknowledge that they comply with and agree to be bound by these Official Contest Rules. Entrants who do not comply with any of these Rules are subject to disqualification at the Sponsor’s sole discretion.

Void where prohibited by law.

## 4. How to Enter

No purchase is necessary to enter or win.

During the Contest Period, eligible participants may enter through Instagram by completing all of the following steps on the official **@uridetech Instagram page**:

- Follow **@uridetech** on Instagram;
- Like the official giveaway post published on the **@uridetech Instagram page**;
- Tag two friends in the comments of the official giveaway post.

Each eligible comment that tags two friends may count as one entry. Entrants may submit additional entries by posting additional comments, provided each additional comment tags two friends and complies with these Official Contest Rules.

Bonus entry: Entrants may receive one additional entry by sharing the official giveaway post to their Instagram story and tagging **@uridetech**, provided the story is visible to the Sponsor and can be verified during the Contest Period.

Private accounts, deleted stories, expired stories, or stories that do not tag **@uridetech** may not be eligible for a bonus entry if the Sponsor cannot verify the entry.

Entries must be received during the Contest Period. Entries submitted before or after the Contest Period will not be eligible.

Entries that are incomplete, inaccurate, false, fraudulent, generated by bots, automated, duplicated in an unauthorized manner, or otherwise irregular may be disqualified at the Sponsor's sole discretion.

Tagging celebrity, brand, bot, or spam accounts may result in disqualification at the Sponsor's sole discretion.

Proof of posting, liking, following, tagging, sharing, or screenshotting does not constitute proof of receipt or eligibility.

No correspondence will be entered into except with selected Entrants.

## 5. Prizes

There are three prizes available in total, with one prize associated with each selected Canada match.

Each prize consists of:

- One ticket to a 2026 World Cup match in which Canada is scheduled to play;
- Round-trip travel within Canada, as determined by the Sponsor;
- Hotel accommodation, as determined by the Sponsor;

All winner announcements are subject to eligibility verification, travel availability, completion of all required documents, and compliance with these Official Contest Rules.

Prize details, including but not limited to ticket category, seat location, travel method, departure city, hotel selection, travel dates, number of hotel nights, and booking details, will be determined by the Sponsor in its sole discretion.

Each prize is for one individual only unless otherwise stated by the Sponsor in writing.

## **6. Travel Conditions**

Travel and hotel arrangements will be booked or coordinated by the Sponsor or its designated representative.

Winners must be available to travel on the dates provided by the Sponsor. Travel dates, travel method, hotel selection, and itinerary cannot be changed once booked unless approved by the Sponsor in writing.

Winners are responsible for ensuring they have valid government-issued identification and any documentation required for domestic travel within Canada.

Winners are responsible for complying with all airline, hotel, venue, ticketing, transportation, public health, safety, and security requirements.

The Sponsor is not responsible for travel delays, cancellations, missed flights, missed connections, weather disruptions, schedule changes, denied boarding, venue access issues, or any other circumstances beyond the Sponsor's reasonable control.

If a winner is unable or unwilling to travel on the required dates, fails to comply with travel requirements, or cannot attend the applicable match, the prize may be forfeited and an alternate winner may be selected.

## **7. Event and Ticket Conditions**

Match tickets are subject to the terms, conditions, rules, and policies of the applicable ticket issuer, venue, event organizer, and any other relevant authority.

The Sponsor is not responsible if any match is cancelled, postponed, delayed, rescheduled, relocated, modified, or otherwise changed for any reason. In such circumstances, the Sponsor may, in its sole discretion and where possible, provide a substitute prize or portion of a prize. No compensation will be provided for any cancelled, postponed, delayed, rescheduled, relocated, or modified match except at the Sponsor's sole discretion.

The prize does not include VIP access, hospitality access, backstage access, meet-and-greet opportunities, team access, player access, merchandise, food and beverage, or any other benefit unless expressly stated by the Sponsor in writing.

Tickets may not be sold, transferred, auctioned, assigned, exchanged, or otherwise used for any commercial or promotional purpose.

Any violation of ticket terms, venue rules, event rules, or applicable laws may result in forfeiture of the prize and/or removal from the venue.

## **8. Winner Selection and Odds**

Potential winners will be selected by random draw from eligible entries received during the Contest Period. The Sponsor expects to announce potential winners on or around **June 4, June 11, and June 18, 2026**, with one potential winner associated with each selected Canada match.

Each potential winner is subject to verification of eligibility, travel availability, completion of all required documents, and correct answer to a mathematical skill-testing question.

Odds of winning depend on the total number of eligible entries received during the Contest Period.

More eligible entries mean more chances to win, provided each entry complies with these Official Contest Rules.

The Sponsor's decisions are final and binding in all matters relating to the Contest.

The Sponsor reserves the right to select alternate potential winners if a selected Entrant is ineligible, cannot be contacted, fails to respond, fails to complete required documentation,

cannot travel, incorrectly answers the skill-testing question, or otherwise fails to comply with these Official Contest Rules.

## **9. Winner Notification and Verification**

Potential winners will be contacted by direct message, email, and/or phone using the contact information available or requested by the Sponsor.

Potential winners must respond within **24 hours** of the Sponsor's first notification attempt. If a potential winner does not respond within the required timeframe, the prize may be forfeited and an alternate potential winner may be selected.

Before being declared an official winner, each potential winner must:

- Confirm compliance with these Official Contest Rules;
- Confirm eligibility;
- Provide valid government-issued identification;
- Provide proof of residence in an Eligible Uride City, if requested;
- Confirm active Uride account status, if requested;
- Confirm availability to travel;
- Sign and return any required Declaration of Eligibility, Liability Release, Publicity Release, and/or travel-related documents;
- Comply with all other requirements set by the Sponsor.

Failure to complete any required step by the deadline provided by the Sponsor may result in disqualification and forfeiture of the prize.

If the identity of a potential winner is disputed, the entry will be deemed to have been submitted by the authorized account holder of the Instagram account associated with the selected entry. A potential winner may be required to provide proof that they are the authorized account holder.

This Contest may be promoted on social media platforms, including but not limited to Instagram, Facebook and TikTok.

This Contest is not sponsored, endorsed, administered by, or associated with Instagram, Facebook, TikTok, YouTube, LinkedIn, X, Meta, or any other social media platform.

By participating in the Contest, Entrants fully release Instagram, Facebook, TikTok, YouTube, LinkedIn, X, Meta, and all other applicable social media platforms from any and all liability related to the Contest.

Any questions, comments, or complaints regarding the Contest must be directed to Uride and not to any social media platform.

## **13. Event / FIFA / Canada Soccer Disclaimer**

This Contest is not sponsored, endorsed, administered by, or associated with FIFA, the FIFA World Cup, Canada Soccer, any participating team, any venue, any ticketing provider, or any event organizer.

All trademarks, team names, event names, venue names, logos, marks, and related intellectual property are the property of their respective owners.

Any references to Canada matches, soccer matches, the 2026 World Cup, venues, cities, or teams are used solely to describe the prize and do not imply sponsorship, endorsement, approval, authorization, or association.

The Sponsor is solely responsible for the administration of this Contest.

## **14. Scam Warning**

The Sponsor will only contact potential winners through Uride's official account, @uridetech, or through official Uride communication channels.

The Sponsor will never ask Entrants to provide credit card information, banking information, or payment in order to claim a prize.

Entrants should be cautious of fake accounts, impersonators, or messages claiming they have won. Any suspicious messages should be reported to Instagram and ignored.

## **15. General Conditions**

The Sponsor reserves the right, in its sole discretion, to cancel, suspend, modify, extend, or terminate the Contest, or any portion of it, at any time and without prior notice if fraud, technical failure, human error, legal restrictions, event changes, travel restrictions, public health concerns, security concerns, or any other factor beyond the Sponsor's reasonable control impairs or threatens to impair the integrity, fairness, security, administration, or proper functioning of the Contest.

If any provision of these Official Contest Rules is determined to be invalid, illegal, or unenforceable by a court of competent jurisdiction, such determination shall not affect the validity or enforceability of the remaining provisions, which shall continue in full force and effect.
